HeterMedia has put in place these internal control guidelines to demonstrate its commitment to data privacy and its assurance for the best efforts in maintaining the information security during the process of data collection, usage, storage and transmission.

Besides, it also illustrates that HeterMedia has continually reviewed different information risks, assessed the implications and formulated systemized measures to limit any threat or damage to the organization. These risk management practices benefit the organization by increasing reliability and security of our information systems.
